# New online tool: Systematic assessment of business-related human rights impacts in the tourism supply chain

Roundtable Human Rights in Tourism is presenting a new online tool for the travel industry to carry out a human rights risk and impact analysis in destination areas.

#### Analysis of human rights risks in the supply chain

The assessment of company-specific human rights risks and impacts along the value chain is an important step in the human rights due diligence of tourism businesses.

With its freely available "Get Started" online tool, the Roundtable Human Rights in Tourism supports tour operators in analysing their supply chain with regard to human rights risks and impacts and in developing individual measures to contain them. ## Assessing human rights impacts in destinations

One way to gain a better understanding of the human rights context of business activities in a destination is to conduct a Human Rights Impact Assessment (HRIA). The "Get Started" tool has now been enhanced with a step-by-step guide to preparing and conducting such an impact assessment. An HRIA conveys and identifies potential and actual impacts of the business activity or local business partners along the value chain. Various local stakeholders and actors are actively surveyed and involved.

The tool follows an internationally recognised methodology, helps to prioritise a country for the implementation of an HRIA and provides concrete and clear instructions for the systematic planning and implementation of an on-site assessment with numerous templates and questionnaires for download. In an internal login area, tour operators can individually evaluate their relevant business-related data. #### Report on exemplary assessment with hands-on recommendations for tour operators

The development of the online tool was accompanied by an exemplary HRIA in Myanmar and Thailand in September 2019.

The methodology and key findings of the assessment are published in a report with hands-on recommendations for tour operators offering travels to Thailand or Myanmar to address human rights risks and define adequate measures. This report is also the basis and starting point for the Roundtable to plan follow-up measures ith involvement of various stakeholders. Furthermore, the Roundtable is planning different webinars regarding aspects of human rights impact assessments for tourism businesses.

It sees itself as an open dialogue platform for the industry-internal exchange and know-how transfer and provides information, materials and good-practice examples.
